

## Changes to how we work out transport options



We want to change the way that we work out transport options for children, young people and their families.



The new tool would work out travel options for a child or young person.



The options would be based on the needs of a child or young person.



Each child or young person would be given a score to help work out their needs and the best transport option for them.

This score will be based on:

- · How well they can move around
- · Their health
- · Their needs
- Their safety
- If they could have training to travel on their own



The tool would help us to choose the best transport that is right for everyone.





 What we will do if a transport vehicle (car, bus, minibus) is damaged on purpose.




 Making sure there is transport for supported internships/ apprenticeships where this has been agreed by the Council.

There will be no change for children and young people using home to school transport now.



If you move school or house after 1 August 2023 new transport options will be looked at.
