



CONSULTATION ON THE PROPOSAL TO INCREASE CAPACITY AT CHETWYND JUNIOR SCHOOL

Introduction

This consultation is being undertaken to advise you of proposals concerning Chetwynd Junior School, and to invite you to tell us what you think of the proposals. This is part of a statutory consultation process that Warwickshire County Council is managing in partnership with the school's Governing Body. The proposal is:

1) To increase the capacity of Chetwynd Junior School by 120 pupils. This would mean the school would move from a three-form entry (3FE) junior school (360 pupils) to a four-form entry (4FE) junior school (480 pupils)

Background

Current pupil forecasts suggest the Nuneaton South East Primary School Place Planning area which covers the areas of Whitestone and Attleborough, will start to face a significant pressure in places as approved housing continues to build out.

The majority of the housing development in this area is located within, or adjacent to, the priority areas for Whitestone Infant School and Chetwynd Junior School. To address the forecast shortfall in pupil places, it is proposed to expand Whitestone Infant School and Chetwynd Junior School by one form of entry. This will permanently increase Whitestone Infant School by 90 places and Chetwynd Junior School by 120 places.

The Proposal

Chetwynd Junior School is currently a 3FE junior school, with an Ofsted rating of Good, with 360 places for children aged 7-11.

It is proposed to increase the number of places for children aged 7-11 by 120 places from 360 to 480 places.

If approved, the Published Admission Number would be increased from 90 to 120 pupils on entry at Year 3. It is proposed the increase to the number of places at the school would start in September 2027 (subject to planning and construction time frames) and roll through each year until the school reaches capacity.

Why is this consultation taking place?

This consultation is part of a statutory process following Department for Education guidelines for making prescribed alterations to schools, which include increasing the capacity of a school.

A consultation was carried out on this proposal during Autumn 2024. The outcome of this consultation was that the LA required further information to fully understand potential

highways measures and associated costs before being able to present a recommendation to Cabinet. Since December 2024, conversations have taken place with Road Safety colleagues relating to parking outside Chetwynd Junior School with the potential for a 'School Streets' Scheme and options to increase staff parking spaces on Whitestone Infant School and Chetwynd Junior School sites have been identified. A further consultation is necessary because of the time that has passed between the first consultation and the present.

Who decides whether the proposal goes ahead?

Following the period of consultation, the County Council's Cabinet will review the feedback and make a decision on whether or not to go ahead with the changes.

Will there be changes to the existing school building?

Capital works are required to ensure sufficient classroom and ancillary space to support the increase in pupil numbers. This additional classroom space can be achieved through a combination of extension and internal remodelling to the existing building.

What about the impact on traffic around the school site?

As part of a planning application, the project team will engage with Warwickshire Highways and undertake a transport study and any required surveys to assess the impact of the development and any potential mitigation.

Will there be any disruption to the existing school while work is being carried out?

The contractors and the school will work together to ensure any disruption to pupils is kept to a minimum and will not have an adverse impact on the pupil's day to day schooling.

What is the proposed timetable?

- 12th September 2025: The County Council's Portfolio Holder for Education gave approval for the proposal to go out for consultation
- 29th September 26th October 2025: A 4-week consultation with parents and other interested stakeholders to take into account the views expressed regarding the proposals.
- 11th December 2025: If Cabinet agree to the proposals, the decision will progress towards implementation.
