# PROPOSED ROAD HUMP (PRIORITY CROSSING FOR PEDESTRIANS AND CYCLISTS) ON ACCESS ROAD TO GREENS HOME AND GARDEN CENTRE OFF A428 RUGBY ROAD, BINLEY WOODS

## PROPOSED CONVERSION OF FOOTWAY TO SHARED USE FOOTWAY / CYCLE TRACK AT A428 RUGBY ROAD, BINLEY WOODS

Warwickshire County Council proposes to construct a road hump on the access road to Greens Home and Garden Centre off the A428 Rugby Road, Binley Woods (as described with approximate measurements in Schedule 1 below) pursuant to the Section 90A of the Highways Act 1980.

Warwickshire County Council hereby further proposes, pursuant to sections 65 and 66 of the Highways Act 1980, to convert parts of existing footways on the A428 Rugby Road, Binley Woods (as described in Schedule 2 below) into a shared use footway/cycle track for use by pedestrians and cyclists.

Located on access road to Greens Home and Garden Centre at its junction with the A428 Rugby Road, Binley Woods.

Road hump dimensions: 7.4 metres (variable width) x 2.6 metres (length) x 0.075 metres (height)

### Schedule 2

### A428 Rugby Road (southern side)

The length of footway on the South side of A428 Rugby Road, commencing at the access road into Greens Home and Garden Centre for a distance of approximately 250 metres with a width varying between 2.5metres and 3.0metres in an easterly direction towards the junction with Oakdale Road.
